 Alderman Purol motioned to approve these appointments; Alderman Thompson seconded it, with all in favor.

Mayor Minor opened the floor for open forum. Sheila Kendrick asked if the City was going to continue with its cleanup efforts that were initiated recently. Mayor Minor said that there is a City-wide clean-up coming up soon which will give the residents of the City an opportunity to get rid of any items that they no longer want. The nuisance abatement procedures are in place; however enforcement is difficult. Fines can be assessed against the offender; however if they claim that they have no money, the City cannot force them to pay. The City will be looking into special assessments against property owners for the cost of abating their nuisance. The special assessment would be similar to a tax bill on their real estate. If they do not pay the special assessment; the City can go through a procedure to sell their property at the Courthouse as if they did not pay their real estate property tax. Heather Wheeler asked why the City cannot bill the property owner for the cost of abating a nuisance on their property and take them to small claims court if they do not pay. Attorney Wilcox said that the City can do this and get a judgment against them, but they City cannot force them to honor the judgement if they claim that they have no money. Mayor Minor said that the City will continue the nuisance abatement program however they are limited in what they can do.

Alderman Thompson presented the Public Works report. Kevin O'Bryan said that the departments were staying busy. The Farmers Elevator project is underway, they repaired a culvert and utility meters will be read next week.

Gary Thompson presented the Public Safety Report. Jackie Pangborn said that Carolyn Erickson visited her today She and Jim Erickson were issued a show cause notice to appear in court on a nuisance violation. They filed an appeal of the nuisance for which they were sited. A nuisance abatement hearing was held but they were never notified of the meeting date and time. Attorney Wilcox said that there are two separate issues. They need to come to court in May on nuisance charge. Mayor Minor said that a Nuisance Abatement hearing needs to be held so that the Ericksons can be heard on their nuisance abatement order. He called a Nuisance Committee meeting for 5:00 pm, Wednesday, April 26, 2017 to review the Nuisance Abatement procedures and Nuisance Abatement Hearing for 5:30 pm that evening so that the Ericksons can be heard on their nuisance abatement order. Tyler Wheeler said that he will notify the Ericksons of the date and time of this hearing.

Alderman Purol presented the Administration Report. Jackie Pangborn presented the Director of Administration's report to the Board of Aldermen:

- At the last meeting it was reported that cost of the engine and installation for 1991 bucket truck would be \$3,800.00. However it was determined that the proposed engine will not work. The Electric Department purchased another engine from J. C. Auto Repair and having them install it at a cost of \$6,000.00. They will guarantee that the engine will fit and they will stand behind it.
- The Swimming Pool personnel have been hired. There will be an orientation meeting for them this Sunday, April 23, 2017.
- She presented information on Elected Official training to be held in June 2017. She asked that if anyone wants to attend this training to contact her.
- The Gas Water Sewer Department wants to purchase a gas detector that will
 detect the level of gases in confined spaces and manholes. They obtained
 three prices. The lowest price was from Schulte Supply in the amount of
 \$1,045.00. This cost would be split between the three departments and come
 from the tools & small equipment budget. The Board approved this purchase.
- The City needs to move forward with the bid from Chester Bross Construction Company to do crack repair and pave the runway at the airport for \$381,562.66. The estimated budget was \$516,766.50. She requested authorization to sign a letter for MoDOT stating that the City recommends

Chester Bross Construction Company to do the project. Alderman Thompson motioned to grant this authorization; Alderman Purol seconded it, with all in favor. The total cost for the Airport Project is \$400,500. The City received a 90/10 grant from MoDOT; therefore the City's share of this cost is \$40,500.00.

- She requested authorization for Mayor Minor to sign the Equipment & Construction Contracts Airport Improvement Sponsor Certification. Alderman Purol motioned to grant this authorization; Alderman Thompson seconded it, with all in favor.
- Jackie Pangborn presented a proposed ordinance which would authorize the Mayor to sign the State Aviation Trust Fund Project Consultant Agreement. The proposed ordinance was assigned bill # 4. The first reading of bill # 4 was read and approved on a motion by Alderman Purol, a second by Alderman Thompson, with all in favor.
